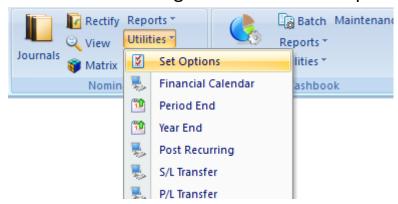



Nominal Ledger Calendar

1) Before you complete your Nominal Ledger Period End for the last period of the year please check your Nominal Ledger Calendar Dates.

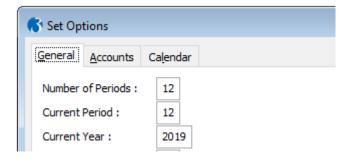
Select Nominal Ledger > Utilities > Set Options







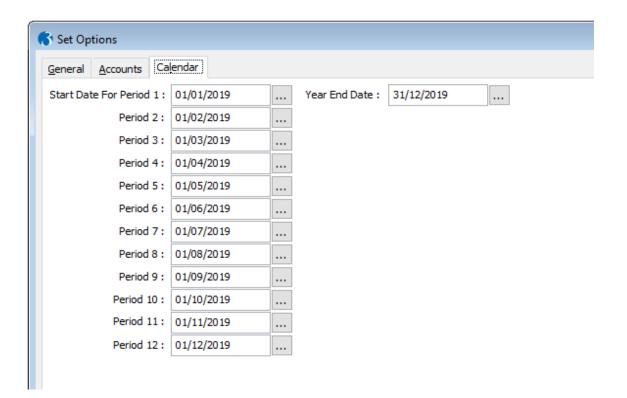
2) Click the OK Button to continue.



3) Click the Calendar Tab

Please note the Year End Date – this SHOULD be the last day of the calendar month




If your Year End Date is incorrect – You must change it before running the NL Period End – once changed, you will get the following alert:






4) Click OK to continue


To do this, select Nominal > Utilities > Set Options > Select Rebuild Periods
